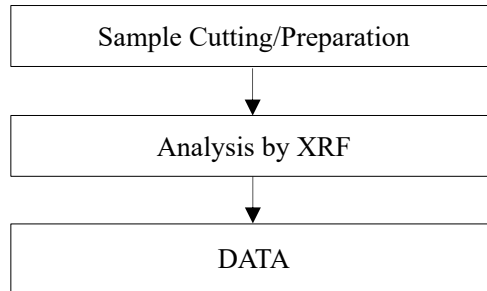

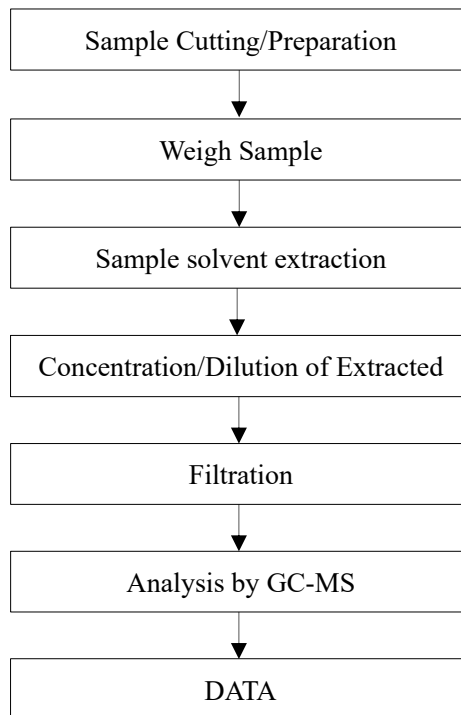

### Test Flow Chart of XRF

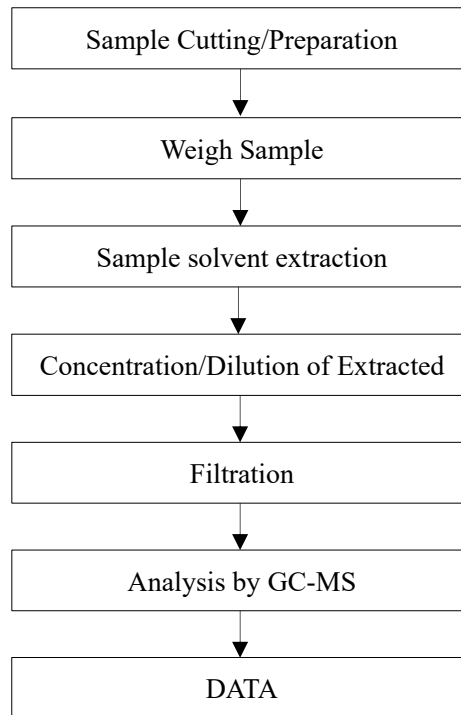


### Test Flow Chart of Phthalates
